Teachers College, 2nd Block, Jayanagar, Bangalore Urban, Bangalore-560011,Karnataka for conducting M.Ed programme of two years duration with an annual intake of 50 students (One units) from the academic sessions 2017-18 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

I. The Endowment fund of Rs.5 lakhs and Reserve fund of Rs,7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDR's shall not be done.

The institution shall comply with the various other norms and standards

prescribed in the NCTE regulations, as amended from time to time.

III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.

IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in

position.

- 2. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body. the State Government etc, as applicable
- 3. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
- If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules,
 Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the regional committee under the provisions of Section17(1) of the NCTE Act.
